Permission to prepare the annual accounts and directors' report in English language

Based on a total evaluation, the view of the tax office is that mentioned companies may make the directors' report and annual accounts in English language according to the Norwegian Accounting Act § 3-4 third paragraph. The exemption requires that the information the decision is based on, does not change significantly.

A copy of this letter must be sent to the Register of Company Accounts in Brønnøysund together with the financial statements. It is incumbent on the company to document by this letter that the permit is granted.

Background

The companies are part of an international group. The group operates in the offshore energy market. English is the company-wide language.

Condition for the permission

According to the Norwegian Accounting Act § 3-4, third paragraph shall "the directors' report and annual accounts (...) be in Norwegian. The Ministry can in an individual decision decide that the directors' report and/or annual accounts may be in another language".

Ot. prp. nr. 42 (1997-1998) About Act about annual accounts etc., says the following about the purpose of the Accounting Act, refer section 1.1:



“The aim of the Government with respect to the Accounting Act is that it shall contribute towards providing informative accounts for different users of accounts. The users of accounts include investors and creditors, which provide capital for the companies. Other groups include those who have an interest in knowing how the companies are operated, for example employees and the local community. The information to the capital market is an important basis for the correct pricing of financial instruments. The correct pricing of stocks is an important factor in securing the best possible allocation of resources in the economy. High quality accounts will also make it more difficult for market participants to obtain speculative gains as a result of non-publicly available information.”

One of the main goals of the Accounting Act is to contribute to “informative accounts for different users of accounts”. The users of the accounts will include investors, creditors, employees and the local community.

Hence, it is the view of the Ministry that it is crucial that the question of dispensation from the general rule that the annual accounts and/or directors’ report should be prepared in Norwegian, not in any significant way deviate from the consideration of users of the accounts.

As mentioned above it is particularly the consideration of the users of the account information, which has to be taken into consideration when considering the application for permission. In this assessment, the tax office has emphasized that the companies are part of an international group. Furthermore, all key players and partners in this industry understand and use English.

1. Accounting Principles

The accounting entity is a Norwegian branch of a foreign Company. The branch has performed work in relation to offshore project in the Norwegian part of the North Sea. The entity has used own employees in connection with work in Norway, but they are not settled here. In addition has there been hired personnel.

The Financial Statements have been prepared in accordance with the Norwegian Accounting Act and generally accepted accounting principles for Small Companies.

1.1 Foreign currency

The books of account of the Company are maintained in Euros.

Monetary items are translated using the exchange rates at the Balance Sheet date. The conversion of income and revenue from EUR to NOK has been done with the Norwegian Bank's average rate in the period of the project.

1.2 Sales revenue

Heavy lift projects in progress at year-end are recorded as follows:

- Accrued project income, contact receivables
Project revenue is recorded in accordance with the percentage of completion method (cost-to-cost).
- Deferred project income, payment on account
The element of actual project invoicing which exceeds the value earned, based on percentage of completion, is deferred and reflected in the Balance Sheet.

Operating revenue:

Operating revenue represents the sum of the amounts invoiced to third parties regarding work performed during the year and includes revenue in respect of projects in progress, recorded according to the percentage of completion method.

Liquidated damages are handled similarly to accrued project income, with the estimated liability recognised as a reduction of operating revenue in the Income Statement.

1.3 Taxes

The income tax expense is comprised of tax payable for the period.

There has not been any National insurance employers contribution to Norway due the employees living abroad. Hired contractors either worked abroad or were employed on Maltese flagged vessels and paying Maltese social security premiums. Payroll expenses included reported salaries to Norwegian authorities. There has not been any payroll in 2024, since the Company did not employ any staff in Norway.

The Branch does not have an occupational pension, because they are not required to have obligatory occupational pension ("lov om obligatorisk tjenestepensjon").

INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the financial statements of Excalibur Marine Contractors Sa, Norwegian branch (the Branch), which comprise the balance sheet as at 31 December 2024, the income statement for the year then ended and notes to the financial statements, including a summary of significant accounting policies.

In our opinion

- the financial statements comply with applicable statutory requirements, and
- the financial statements give a true and fair view of the financial position of the Branch as at 31 December 2024 and its financial performance for the year then ended in accordance with the Norwegian Accounting Act and accounting standards and practices generally accepted in Norway.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs). The General Manager (management) is responsible for the preparation of the financial statements that give a true and fair view in accordance with the Norwegian Accounting Act and accounting standards and practices generally accepted in Norway, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Branch's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Branch or to cease operations, or has no realistic alternative but to do so.
